The above result has been compiled in ascending order of the roll numbers of candidates. Any claim for merit position on the basis of this notice will not be accepted.

- 7. The candidates who want to get their papers rechecked are advised to apply along-with original online deposit receipt of Rs.200/- as rechecking fee within 07 days of the declaration of this result. After which no request for rechecking/recounting of marks will be entertained.
