1. The candidates are provisionally admitted to the above examination. Before appearing in the examination, candidates should ensure that they fulfill all the eligibility criteria for the post(s) as prescribed in Advertisement No. 05/2026, including the following requirements, by the closing date of the advertisement:
 - a) He / She must possess at least second class Bachelor's Degree or Equivalent qualification from a recognized University.
 - b) He / She have satisfactorily completed the probation period and has been confirmed in the rank of Assistant Sub Inspector.
 - c) He / She have not been awarded any major penalty during the last three (03) years.
2. The examination schedule is provisional subject to availability of examination halls.
3. Syllabus & course contents may be downloaded from KP PSC website i.e., www.kppsc.gov.pk.
4. Candidates must reach the examination centre within 30 minutes of the reporting time thereafter the main gate will be closed.
5. Call letters of candidates concerned will be uploaded on KP PSC official website i.e., www.kppsc.gov.pk. Candidate concerned may download their call letters / roll numbers slips 15 days before the examination.
6. Candidates concerned would be required to get print of the call letter/ roll number slip and take it along with original computerized national identity card (CNIC) to the examination hall on the scheduled date/ time.
7. Without call letter and original CNIC, no candidate will be allowed to enter the examination centre.
8. Candidates concerned who do not get intimation through website or SMS or e-mail may confirm their status from KP PSC office by personal visit or through Telephone No. 091-9212976/ 9214131/ 9213750/ 9213563 (Ext No.105, 113).
9. Carrying mobile phone, electronic gadgets and any other helping material to the examination hall are strictly prohibited which may lead to disqualification of the candidate(s) concerned.
10. All the candidates are required to confirm their roll numbers and location of examination centre(s) one day before the date of the examination to avoid any inconvenience.

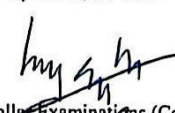
