HELD W.E.F 20TH NOVEMBER TO 4TH DECEMBER, 2025. ADVERTISEMENT No. 02/2025 (Sr. No. 1 & 2).**

The Khyber Pakhtunkhwa Public Service Commission conducted written examination for fifty five (55) posts of Provincial Management Service Officers (BPS-17) and twenty two (22) posts of Assistant Excise and Taxation Officers (BPS-17) (Advertisement No. 02/2025, serial No. 1 and 2), w.e.f. 20th November to 4th December, 2025.

2. In response to the said advertisement, total 43989 applications were received. Shortlisted 9896 candidates admitted to written examination as per prescribed syllabus wherein 5071 candidates appeared out of which **only fifty (50) candidates** succeeded to qualify. The above Fifty (50) qualified candidates shall submit their requisite documents along with duly signed Documents Submission Proforma available on KPPSC website, to the Commission in a manner that the same reach the Commission's office upto 21.09.2026 i.e. within 15 days of the issuance of this intimation, as prescribed in Regulation 12(c) of the KP PSC Regulation 2017.

4. Detailed Marks Certificates of candidates who could not qualify are available on KP PSC website (www.kppsc.gov.pk).

5. A candidate who desires to apply for re-totalling of marks, he /she shall submit an application to the Commission along with a challan of Rs. 500/- per paper deposited in the relevant head of account in National Bank of Pakistan within fifteen days after announcement of the result. Challan form can be downloaded from the KP PSC website. No request for retotalling, after expiry of the said period shall be entertained.
