REVISED NOTICE

In continuation to earlier notice dated 03-11-2025, in which the Punjab Public Service Commission shortlisted 11 candidates for scrutiny of documents. As a result of scrutiny of applications, 04 candidates were rejected before interview. 07 were finally called for interview. 02 candidates remained absent in the interview and 05 candidates failed in interview. Therefore, in the light of PPSC Policy Decisions – 2022 [P.D.17.5 (a)] the following next **10** available candidates in the merit list for recruitment to **02 POSTS (OPEN MERIT) OF ASSISTANT DIRECTOR CONTRACT (SERVICES) (BS-17) (ON CONTRACT BASIS FOR A PERIOD OF THREE YEARS EXTENDABLE) IN THE PUNJAB RING ROAD AUTHORITY (C&W DEPARTMENT)** have been provisionally cleared for interview as a result of written test held on 18-10-2025.
